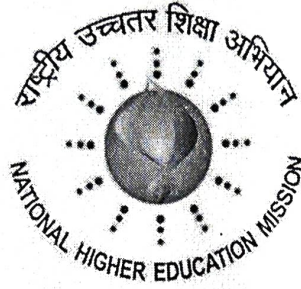

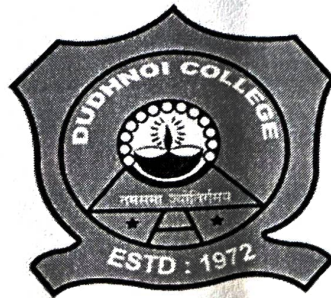


This Memorandum of Understanding (MoU) shall focus on the following areas:

- D. Joint organization of seminars, conferences, workshops, lectures, and other academic Programmes, along with mutual participation in such activities.


Commencement, Renewal, Termination and Amendment




